3. Any person wishing to commercially operate the Orgo-Life® Quantum MedBed Energy Technology® must sign a new contract with Orgo-Life® and receive official approval.

## SECTION 2: RESALE PROCEDURE

4. Notify Orgo-Life® before any transfer of the kit and submit complete information of the potential buyer.
5. Orgo-Life® conducts compliance verification of the buyer.
6. The new buyer must complete and sign the Orgo-Life® Independent Therapist/Reseller contract.
7. The new buyer pays the annual registration fees:
  - o \$120 for the annual operation license
  - o \$240 for advertising and official directory listing
  - o Total annual fee: \$360 (+ taxes)
8. A certificate of compliance is issued to the new reseller.

### SECTION 3: ITEMS THAT ARE TRANSFERABLE

9. Physical equipment: Orgo-Life® Quantum MedBed Energy Technology® accessories, modules, posters, displays.
  10. Physical promotional material received during initial registration.
  11. Possibility to transfer previous training documents for reference only (non-contractual).

### SECTION 4: ITEMS THAT ARE NOT TRANSFERABLE

12. Access to existing web accounts, platforms, and IT systems.
  13. Orgo-Life® email addresses associated with the original reseller.
  14. Personal certificate of compliance number of the former reseller.
  15. Network and previous commissions history.

### SECTION 5: CONTRACTUAL RESPONSIBILITIES AFTER RESALE

16. The new buyer starts operations under their own independent contract.
  17. The former reseller remains responsible for their own past statements and commitments.

  19. The buyer may not operate under the brand without written authorization from Orgo-Life®.

  21. Exclusive use of formulations approved by Orgo-Life® for public communications.
  22. Strict respect of fixed pricing and Orgo-Life® pricing policy.
  23. Absolute prohibition of mixing the Orgo-Life® brand with other competing products.
  24. Obligation to use official visuals, logos, and documents provided by Orgo-Life®.

### SECTION 7: TERRITORY AND REPRESENTATION

25. The currently authorized territory is Canada. Any international expansion requires specific approval (e.g. new centers in California, USA, Costa Rica, and upcoming Mexico locations).

The resale of the Orgo-Life® Quantum MedBed Energy Technology® kit is allowed, provided that the procedure is strictly followed. The Orgo-Life® model operates under a protected contractual structure, allowing each individual to operate the technology in a secure, legal, and equitable framework.

Any deviation from these rules may result in revocation of the operating license.
